## **PRESBYTERY EXECUTIVE COMMISSION**

CRE Bong Bringas reported for the commission

The San Gabriel Presbytery Executive Commission met on February 28, 2017, with a quorum present, and gives the following report.

## **DECISIONS MADE ON BEHALF OF THE PRESBYTERY**

1. Approved the application to PILP for a mortgage of \$2.4 million, with fixed interest of 4.5% over 20 years, for the purchase of the Temple City Christian Church property. [Note: Purchase was approved by Presbytery in November 2016, to house the Grace Taiwanese and Mideast Evangelical churches, the offices of San Gabriel Presbytery, and an independent non-profit preschool. Income from the four entities using the space will provide for the monthly mortgage payments. \$1,000,000 from upcoming property sales by the Presbytery will reduce the indebtedness by that amount within a year. It is possible that the Presbytery will also apply for a “Restoring Creation” loan at 3.5% interest for repairs and upgrades such as solar panels, accessible bathrooms, etc.]
2. Approved rental of the smaller chapel at Korean Good Shepherd church during defined hours by Gospel Light Bible Church for \$1,800/month. The initial lease will be 1 year, starting March 1, 2017.
3. Approved received the Independent Accountants’ Review Report for 2015.
4. Elected Ben Furuta (RE; Calvary) to the Personnel Committee, Class of 2017, as its Moderator.
5. Received from First Presbyterian Church of Altadena the project report on its Congregational Transformation and Growth Grant, approved the request to extend the grant from 5 years to 6 years, and approved their request to disburse the final installment of funds of \$33,333 (\$16,666 from the Synod, \$16,667 from the Presbytery).

## **FOR INFORMATION**

1. Received report from Administration and Finance Committee of the approval of the sale of two parcels of land by Arcadia Community Church. The A&F Committee was authorized to approve this sale by the Presbytery.

2. Primera Iglesia Presbiteriana de Rosemead's sale of their Rosemead property formally closed February 27, 2017. They are in escrow with the Del Haven Christian Church property in La Puente and are currently transitioning to that location.
3. The team appointed to work with Alhambra True Light as it discerns its relationship with the PC(USA) has begun working with the church. The members are TE Larry Ballenger, RE Pat Martinez-Miller, TE Jeff O'Grady, and TE Mariko Yanagihara.

## **RECOMMENDATIONS FOR PRESBYTERY APPROVAL**

CRE Bon Bringas invited TE Dave Tomlinson to give the following portion of the report.

1. It was M/S/V to market the property of the former South Hills Presbyterian Church through Berkshire Hathaway (Lynette Sohl) for the highest offer possible, with an asking price of \$3,100,000. Further, that 1/3 of the sale proceeds be set aside for creative multi-cultural ministry utilizing the cultural gifts of the Black church that would honor the vision and ministry of the former South Hills congregation.
2. It was M/S/V to market the property at 5116 Irwindale, Irwindale, through Berkshire Hathaway (Lynette Sohl), with an asking price of \$988,000. [NOTE: while Mideast Evangelical Church has been using this property for parts of its ministry; the sale proceeds will be used towards the purchase price of the new Presbytery Center in Temple City, which will house MEC and all its programs.] TE reported that this property housed the first Hispanic Presbyterian Church in the Presbytery of San Gabriel.
3. It was M/S/V to approve the sale of cell tower wireless-leases by Village Presbyterian Church, Arcadia, to AT&T for \$400,000 to be paid in equal installments (\$40,000) over ten years. [NOTE: any increases in the wireless leases in that period would be shared equally by AT&T and the Village church. The church now receives \$27,750 per year from the current lease.]

## **ADMINISTRATION AND FINANCE COMMITTEE**

TE Dave Tomlinson reported for the committee.

TE Dave Tomlinson reported that First Presbyterian Church, Rosemead will be searching for a new name as they move into their new facility in La Puente; they will be hosting the September Presbytery meeting in their new location.

TE Tomlinson showed pictures of the property on Garibaldi Avenue in Temple City which will house Grace Taiwanese Presbyterian Church, Mideast Evangelical Presbyterian Church and the Presbytery Offices. This property is also home to a thriving pre-school, Play Factory.

The building at 630 N. Dalton Avenue, Azusa, the former home of the Presbytery of San Gabriel, will be offered for lease at rate of \$5,000 per month.

## **GA AMENDMENTS – Presented by the Education Committee**

TE Jennifer Ackerman reported for the committee.

TE Jennifer Ackerman walked the presbytery through proposed amendments, 16-A, 16-B, 16-E, and 16-F. After an opportunity for questions and discussion, it was M/S/V to approve amendments 16-A, 16-B, E-16 and 16-F.

TE Ackerman explained proposed amendment 16-C. After an opportunity for questions and discussion, it was M/S/V to approve amendment 16C.

TE Ackerman explained proposed amendment 16-D. The Presbytery addressed amendments 16-D.1 and 16-D.2 separately. After an opportunity for questions and discussion, it was M/S/V to approve amendment 16-D.1. After an opportunity for questions and discussion, it was M/S/V to approve amendment 16-D.2.

TE Ackerman explained proposed amendments 16-G and 16-H and that if amendment 16-H is passed, the language in 16-G is automatically included. The presbytery addressed amendments 16-G and 16-H separately. After an opportunity for questions and discussion, it was M/S/V to approve amendments 16-G. After an opportunity for questions and discussion, it was M/S/V to approve amendment 16-H

### **PRESBYTERY OFFERING**

The offering at today's meeting will go to the benefit of the upcoming Youth Trip to Peru. Mission Advocate, Wendy Gist spoke about the upcoming Youth Trip to Peru; the last trip was in 2012. The group going to Peru is made up of 9 youth, 2 young adults 3 adults. This will be a Cross-Presbytery trip including youth from Riverside Presbytery. There is a group fund raising effort with a goal of each participant raising \$1,100. Two of the participants of the trip, Mario Balonos and his daughter Lily spoke about their excitement and hopes for the trip. Part of the efforts of the youth will include Vacation Bible School and work at an orphanage.

Mr. Sang Lee and Ms. Yoon, members of Divine Light Presbyterian Church, provided special music during the offering.

### **COMMISSION ON MINISTRY**

TE Cyndie Crowell reported for the commission. The Commission on Ministry met on Monday, February 6 and Monday, March 5 and brings the following recommendations to the Presbytery --

**It was Moved, Seconded and Voted to approve the omnibus motion as follows:**

#### **OMNIBUS MOTION:**

1. To dismiss TE Mark Smutny to the Seattle Presbytery upon his receipt by that Presbytery. Rev. Smutny will be serving as the Interim Pastor of the Redmond Presbyterian Church, Redmond, WA.
- 2a. To dismiss TE James Baird to the Presbytery of Santa Barbara upon receipt by that Presbytery and  
b. to concur with the congregation of San Marino Community Church to dissolve the Associate Pastor relationship with TE Baird effective January 31, 2017.
3. To dismiss TE Rocky Supinger to the Presbytery of Chicago where he has already been received.
4. To renew TE Erick Dailey's contract with the Occidental Presbyterian Church, Eagle Rock at the current terms of call and responsibilities.

The Commission on Ministry recommends that the Presbytery:

3. It was M/S/V to receive TE Jen Strickland into membership from the Homestead Presbytery. Jen is a graduate of Princeton Theological Seminary and is serving a co-pastorate with her husband at the Claremont United Church of Christ.
4. It was M/S/V to receive Honorably Retired TE William Van Loan into membership upon his dismissal from the Los Ranchos Presbytery.

All those new members were invited forward for prayer with and by the Rev. Cynthia Crowell.

**INFORMATION ONLY:**

1. TE Lauren Evans has been hired to be the Presbytery's Chaplain for Retired Church Workers. Lauren is a member of the San Gabriel Presbytery and works part time at the LaVerne Hts. Presbyterian Church. She began her service as Chaplain for Retired Church Workers on March 1.
2. COM approved the Ministry Information form for Korean Good Shepherd Presbyterian Church, Rowland Hts.
3. COM granted permission for Pasadena Presbyterian Church to begin the search for an installed pastor for the Korean ministry.

**Presbytery took a 10 minute break and returned with Becca Bateman, Vice Moderator, moderating for the rest of the meeting.**



## **CHAPLAIN FOR RETIRED PRESBYTERIAN CHURCH WORKERS**

TE Lauren Evans started with a reading from scripture and spoke about her position as Chaplain for Retired Presbyterian Church Workers and her hopes and goals for her new ministry as friend and companion on the journey for the presbytery's retired members as they investigate their calls and interests at this time in their lives.

## **VISION AND STRATEGY COMMITTEE**

TE Jonathan Hughes Reported for the committee.

Rev. Hughes asked the presbytery to keep our New Worshipping Communities in prayer.

The committee has been working to set benchmarks for those worshipping communities who have received the initial seed grant to move to the next step in the grant process. He invited the presbytery to let the committee know if they have any ideas or desire to form a new worshipping community.

### **JUSTICE, PEACEMAKING AND MISSION**

Wendy Gist introduced TE Elizabeth Gibbs Zehnder, chaplain at LA County USC Hospital. Rev. Gibbs Zehnder said that, as a trauma center, a very broad spectrum of the community uses the

services at the hospital. She said that when push comes to shove, even those people who profess no faith, are open to seeking the Divine. She spoke about the ways that the presbytery can serve.

RE Carolyn Harris spoke on a Synod event to take place on April 22<sup>nd</sup>, 8:30AM – 1:00PM, at Grace Presbyterian Church, Long Beach – *No Way to Treat a Child: Where's the Hope for the Palestinian Family?* Topics will include incarceration and health and nutrition as well as other topics

Wendy Gist introduce the new Director of La Casa de San Gabriel, Lisa Gutierrez-Correa. Lisa has been the new director for only a month and said that most of the families who visit La Casa are living at or below the poverty level. She invited members of the presbytery to visit La Casa to see the facility and what they are doing to serve the community.

Wendy Tajima offered prayer for La Casa and Lisa, for TE Lauren Evans, for TE Elizabeth Gibbs Zehnder, and for our Presbytery.

Wendy Gist thanked those churches who take part in the One Great Hour of Sharing offering and encouraged others to participate as well. She explained that portions of the offering go to Self-Development of People, to Presbyterian Disaster Assistance and to the Presbyterian Hunger Program.

Wendy Gist explained that the June 17<sup>th</sup> Presbytery meeting will be a service-oriented Presbytery meeting. The business portion of the meeting will be very short and then those attending will be sent out to sites to do service. Presbytery members were invited to let committee member know about possible service site especially those churches in our presbytery who are in need of service. Those churches with needs were invited to sign up with Young Lee Hertig, Carolyn Harris or Wendy Gist during lunch. The presbytery's middle school mission will take place at the same time and they will be working alongside us.

The San Gabriel Presbytery Executive Commission met on May 9, 2017, with a quorum present, and gives the following report.

**RECOMMENDATIONS FOR PRESBYTERY APPROVAL**

1. Upon recommendation of the Vision and Strategy Team, the Executive Commission voted to recommend that Presbytery provide a grant of \$7,908 to be distributed for June-August 2017 to Church Glorious through the Vision and Strategy Team. The grant would allow financial support for organizing pastor Rev. Kerry Allison for three months, as well as financial support for Sound/Music and Events, Social Media and an assistant. Funds will come from an account designated for Church Growth and Renewal. This item will be presented as part of the Vision and Strategy report to the Presbytery on June 17, 2017.
2. The Executive Commission voted to nominate Rev. Angel de Rosas to the Committee on Representation and Nominations, Class of 2019. This item will be presented as part of the Committee on Representation and Nominations report to the Presbytery on June 17, 2017.

**DECISIONS MADE ON BEHALF OF THE PRESBYTERY**

3. Glendale Korean Presbyterian Church currently has a three-person Administrative Commission, but one person, Rev. David Chai, resigned as he has moved back to Colorado. On behalf of the Presbytery, the Executive Commission voted to add Rev. Dongwoo Lee to the AC. In addition, the Executive Commission voted to authorize COM Moderator Cyndie Crowell to appoint two more members for the Administrative Commission and to report those names to the June Presbytery Meeting. The two ruling elders of the church, and the pastor, were added to the commission:

4. Contribution Statements – For individuals contributing funds to the Presbytery through offerings or other monetary donations, a contribution statement has been prepared and will be made available on an honor system at the clerk's table at presbytery meetings, or through the Presbytery office for donations between meetings.
5. The property on Dalton Street in Azusa has been prepared for lease. There was a question from a potential lessee that the second floor be subleased. It was approved that subleasing of the second floor be allowed as long as the primary lessee remain responsible for the full amount of the lease.
6. The property in Pomona for the former South Hills church is on the market, but has been subject to vandalism. A former member of the church, Don Sevesind, has been visiting and making repairs to the property as needed. The Trustees of the Presbytery has compensated him for this. When the property is sold, one third of the proceeds will go to a new church development that continues the legacy of South Hills, and \$1,000,000 will be used to pay down the loan on the Temple City property.

7. First Presbyterian Church Rosemead has moved to their new building in La Puente. They are vetting a new name, Puente de Esperanza (Bridge of Hope).
8. The Irwindale property is in escrow and should close some time in June. A gift of at least \$50,000 will be given to Mideast Evangelical Church to offset some of the funds they invested in the Irwindale property. \$600,000 will go back into the Presbytery's reserves, to replenish what was used for the down payment on Temple City.
9. The Temple City property at 9723 Garibaldi Avenue has closed escrow and is now owned by the Presbytery, thanks to PILP staff in approving and funding the loan in a very short period of time. The presbytery office has moved into the property, thanks to the heroic efforts of Twila French and the rest of the staff.
10. The Executive Commission discussed plans for the June 17<sup>th</sup> Work Day. The offering that day will go to the Tapestry Youth Collective, who will join the Presbytery for the Work Day.


I believe that the worship experience connects us with God through prayer and reflection, through music and singing, through the spoken preaching of the Scripture, and through the fellowship of believers.

Walter Contreras:** Rev Contreras is a Pastor of the PPC Pasadena Presbyterian Church, Walter serves as a member of the Justice, Peacemaking and Mission Committee, and is a certify member of Presbyterian committee on the Self- Development of People (SDOP) of the Presbytery of San Gabriel.

Walter was the charter member and co-founder of the Hispanic congregation of The Crystal Cathedral in Garden Grove, California of the Reformed Church of America (RCA). He also served in the Methodist church as pastor and Director church planting and Justice ministries, He has served as an Associate Superintendent and Coordinator of Hispanic Ministries for the Evangelical Covenant Church, Director of Outreach and Hispanic Church Planting for the Pacific South West Conference a region of the Evangelical Covenant Church. He has planted churches for the ECC outside the PSWC conference: Salina Kansas, Indianapolis, Chicago and Minnesota. He also held the position of Director of Mobilization and Connection for the Department of World Mission of the ECC. He also has served as a consultant for Esperanza USA in California, Tucson and Tacoma. He is in an advocate, activist and organizer for CLUE-LA (Clergy and Laity United for Economic Justice).. He has served as vice-president of NALEC (National Latino Evangelical Coalition) NALEC has a membership of more than 3.000 congregations and Institutions. Walter is the son of missionary parents that founded the 'Missionary Christian Movement' and indigenous church planting movement in Latin America and Europe. He grew up in the urban City of Buenos Aires among many orphan children that his parents adopted as part of one of the many ministries his father and mother started during the "Dirty War", a time when the military government in Argentina was accused for the disappearance of over 30.000 people. During the time of much turmoil in the late 70' Walter Contreras came to the USA to finish his education and became part of the Brooklyn Gospel Tabernacle in New York city; This church sent Walter Contreras as a Missionary to Paraguay in 1981 were he worked as a High School teacher in 'Asuncion Christian Academy', and also served an Indigenous church of Guarani Indians in the city of Asuncion Paraguay. After three years of serving as a missionary he returned to his home church in New York City. He served the Fred Jordan Mission as the Executive Director he became a strong advocate and activist for the homeless and the Hispanic population. During this time, he completed his graduate studies earning a Master of Divinity in Multicultural Studies 1997 from Fuller Theological Seminary.

During these 15 years he also worked with other organizations that served the Hispanic population of Southern California: TV co-host for HCCN (Hispanic Communication Network) a two-hour live TV program aired in Telemundo. His passion for community development and community transformation in ministries of compassion, mercy and Justice has always driven his heart.

Walter is also a member of the LACRL (Los Angeles Council of Religious Leaders)
